This complaint is based upon the NCIC printout and Missouri warrant, which shows that the Defendant is wanted for Statutory Rape 1st, Statutory Sodomy 1st, Child Molestation 1st (X2), Incest, by the State of Missouri. The defendant was contacted for arrest.

Further, based upon the arrest of the Defendant by Trooper Sheets on 8/29/2014, for being a Fugitive from Justice. The Defendant was identified by the following:

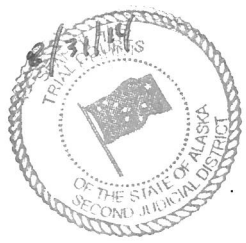

On 8/28/2014, Trooper Sheets contacted Andrew County Sherrif Bryan L. Atkins, who confirmed that the warrant was outstanding and the State of Missouri would pursue the extradition of the Defendant.
